intend to consolidate and expand the promotion of common interests in local government, education and scientific and cultural cooperation on the basis of existing partnership relations at municipal level.

The cooperation is based on the 17 Sustainable Development Goals (SDGs) of the 2030 Agenda.

The following goals are pursued jointly on an ecological, economic and social level.


- Establishment of networks for knowledge transfer and technical/technological support in the areas of:
 - Recycling
 - Water
 - Waste water
- Initiation of an administrative exchange between the local administrations with a focus on the following areas:
 - Optimization potential in the organizational processes of daily business
 - Establishment of a support network
 - Opportunities for technical support

- Development and support of a business network to help find investors for Lüderitz (Namibia)
- Initiation of a training project with the target of enabling young people from Lüderitz (Namibia) to receive training in the Tanagerhütte
- Learning support - "German as a foreign language" by:
 - Contact mediation between school coordinators
 - Promoting the exchange of teachers and pupils
- Establishing networks and channels for rapid direct aid through donations, e.g. through:
 - Initiation of a "Lüderitz Day" in Lüderitz
 - Support for educational programs for women
 - Initiation of association and company partnerships


In order to live the partnership, fixed contact persons are appointed on both sides and regular communication is agreed every two months.


